#### **Discretionary Housing Payments**

Discretionary Housing Payments are made towards housing costs where a person receives Housing Benefit or the housing element of Universal Credit and they need help with: a shortfall in rent, an advance in rent or a deposit, removal costs, or rent arrears.

#### **Pension Credit**

Pension Credit is a tax-free means-tested benefit aimed at retired people on low incomes. If eligible you could be entitled to access other benefits such as council tax discounts and free TV licences for the over-75s. Around 850,000 eligible households aren't claiming this benefit which they are entitled to.

#### **Entitledto**

Entitledto helps people determine what they can claim from national and local government via their self-serve calculators. They provide a reliable estimate of benefit entitlements based on their in-depth knowledge of the UK's social security system.

#### **Marriage Tax Allowance**

You can benefit from Marriage Allowance if all the following apply: you're married or in a civil partnership; you do not pay Income Tax or your income is below your Personal Allowance (usually £12,570); and, your partner pays Income Tax at the basic rate, which usually means their income is between £12,571 and £50,270, before they receive Marriage Allowance.

#### **Thames Water Help Schemes**

Thames Water have schemes to reduce water bills on some low-income households, households with large families and those who have a water-dependent medical condition. They consider households earning below £16,480, or below £20,111 in London boroughs, to be on a low income.

## **CHILDREN AND FAMILIES**

#### **Healthy Start Scheme**

If you're more than 10 weeks pregnant or have a child under 4, you may be entitled to get help to buy healthy food and milk. You'll be sent a Healthy Start card with money on it that you can use in some UK shops to buy items such as: milk; fresh, frozen, and tinned fruit and vegetables; instant formula milk; Healthy Start vitamins.

#### **Sure Start Maternity Grant**

A one-off payment of £500 to help towards the costs of having a child. You usually qualify if you are having your first child, or if you are expecting a multiple birth, and if you or your partner receive certain benefits.

#### **Homestart**

Home-Start Croydon is a voluntary organisation committed to promoting the welfare of families with at least one child under five years of age. They support parents in their own homes with trained volunteers - https://croydon-homestart.co.uk/



#### **Tax Free Childcare**

You can get up to £500 every 3 months (up to £2,000 a year) for each of your children to help with the costs of childcare. For every £8 you pay into this account, the government will pay in £2 to use to pay your provider. You can get Tax-Free Childcare at the same time as 30 hours free childcare if you're eligible for both.
